

Introduction On October 29, 2003, Jefferson County Sheriff Ted Mink asked Attorney General Ken Salazar to investigate the origin and history of a document concerning the April 1999 shootings at Columbine High School. The document is a Sheriff's office 1997 "directed report" concerning Eric Harris, one of the Columbine murderers. This report had just been discovered, tucked into a binder notebook. The 1997 directed report was, at the time it was found in 2003, the earliest known law enforcement reference to Eric Harris in the Jefferson County Sheriff's Department. To aid in this investigation, the Attorney General sought the assistance of an independent Sheriff's office. Adams County Sheriff Doug Darr graciously assigned an investigator to work with the Colorado Attorney General's Office. The Adams County investigator brought valuable knowledge of Sheriff's department practices and procedures to this investigation and was instrumental in the formation of investigative strategies. This investigation consists primarily of interviews of involved parties and a careful review of records in the Jefferson County Sheriff's Department. Information was sought in the interviews conducted and follow-ups often occurred. Forensic analysis of handwriting was also undertaken to determine the identity of the "concerned citizen" described below. No individuals we contacted objected to being interviewed.
